

day for an adventure!"









Cubby pulls Coco down the cobblestone street. As they reach the park, Cubby suddenly stops and tilts his head up. "Do you hear that?"

Cubby thinks, counting in his head. "I think we will need twenty dollars. Here." Cubby reaches into his chest pocket. "How much money do we have all together?"


"Seven dollars plus five dollars equals twelve dollars," Coco beams.







"Oh, thank you, Cubby and Coco!" Mr. Squirrel gasps, gratefully.




The two friends run over and ease the bags down into the wagon.


They chat cheerily with the elderly squirrel along their walk, and help him carry the bags into his home.

He hands each of them one golden dollar coin. Cubby and Coco add the coins to their collection and count them all together.







Cubby shakes his head. "Oh no. We are not stopping. We have a goal! We have a birdhouse to build!"


He pulls her along. Coco glances back longingly at the bright colorful tubs of ice cream.

Coco frowns, disappointed. "But the paint will make the home beautiful for our little friend!"


Cubby sighs and nods, "Yes, but we need to make choices. Let's see. What if we only buy three colors: red, yellow, and blue?

Hints for Reading Cubby and Coco with a child (ren):

- Set aside technology and other distractions
- Pause to give time for the children to sound out the word
- Take turns reading out loud
- Stop reading at different points, discuss what has happened . . . imagine what is next
- PRAISE your reader(s)
- Use \$20.00 (coins and dollars)
 while reading the story to
 reinforce counting coins and
 coin recognition. 15 dollar bills and/or coins,
 14 quarters, 12 dimes, 5 nickels and 5 pennies.

Need: Something we must have to survive

Pasic Needs: Essential items for survival. Food and water, home (rent or mortgage), clothing, transportation, healthcare, and air

Want: Something we would like to have

Budget: A plan for how you will spend and save your money

Financial Decision: A choice you make about how to spend and save money

Emergency Fund: Money you save to pay for the cost of meeting needs when unexpected things happen

Goal: Something you want to achieve in the future




- What needs and wants were important to Cubby, Coco, Mr. Squirrel and the robin?
- Describe how Cubby and Coco earned their money. Did Cubby and Coco have a goal and a plan for their money?
- Did Cubby and Coco have to make a financial decision (ice cream) about their money? Why was Cubby a good friend?
- Was there an emergency that Cubby and Coco encountered?
- Did Coco and Cubby have money left over?
 Did they have a plan to spend this money?



Group Sharing on Financial Well-Being:

- Do you get an allowance? How do you spend and save your money?
- Have you ever wanted an item and you were told that you had to wait or couldn't have the item? Was it a need or a want?
- Do you have a savings account? Are you waiting to buy something?
- If you had 20 dollars, how would you spend your money? Discuss the 50/30/20 method for savings and spending (50% for needs, 30% for wants, 20% for saving).
- Is there something in the classroom we need an emergency fund for?



Sharing and Caring

Broadview FCU supports helping youth understand how to develop self-management skills, healthy relationships, working with personal and community resources, and asking for help for self and others.


- Cubby and Coco like adventures together, how do they physically get around? Is walking good for you?

- How do Cubby and Coco positively impact their corner of the world?




Group Sharing

- If you had extra money to give, how would you help others?








Cubby and Coco's Birdhouse Bank

Instructions:




- 2. Cut **BLUE** slots for tabs.

5. Fold all **RED** and **GRAY** tabs.

- 6. Prop birdhouse up with **GREEN** base facing down.
- 7. Layer **B**ASE sections on top of each other to create cube.

8. Insert **RED** tabs into **BLUE** slots.


